## **UK Contingent Data Privacy Statement**

The Scout Association (TSA) may contact you or your child (where you are applying on their behalf) with regards to Roverway 2024 or related events for a period of up to 5 years post the end date of Roverway 2024, for the purposes of gathering information, including regular surveys for Roverway 2024 or to facilitate support to future UK Contingents including the next Roverway.

We're committed to protecting the privacy of all personal data you provide us for this event registration. The following statements describe what we're doing with this data and how long we store it. This means you are fully informed prior to you submitting the personal information for you or your child's (where you are applying on their behalf) event registration.

We ask for this personal data to facilitate registration for this event. We'll only collect information necessary for participation at Roverway 2024 and for our equality monitoring of the event where data is collected only for monitoring purposes it will be separated from your records and stored anonymously. However, the data required for the operation of the event will be retained in an identifiable format. This can include sensitive personal data, such as information on disability and health conditions.

This data will be shared with other organisations and third parties to process the registration and facilitate your participation. This will include:

- The Guides and Scouts of Norway;
- YMCA and YWCA scouts of Norway;
- Norwegian Guide and Scout Association;
- World Organisation of Girl Guides and Girl Scouts (WAGGGS)World Organisation of the Scout Movement (WOSM);
- Third party suppliers required for the organisation of the **Event** such as travel companies, hotels etc.

Only relevant data will be shared with such parties. These may include:

- Our event management system (EventsAIR);
- Travel providers (including Travel Places);
- Members of the UK Contingent and The Scouts (including your relevant County/Nation/BSO); and
- Any other organisation that may reasonably require your data to enable participation at Roverway 2024.
- Other local organisations engaged to assist with the event.

Photos or videos may be taken during this event by an official photographer, a member of the UK Contingent Management Team (CMT) or International Service Team (IST), and these may occasionally be used online or in printed literature by the Scouts or our event partners. By attending this event, you acknowledge to the possibility of being photographed and your image

(or that of your child, where you are applying on their behalf) being used in this manner. We will not seek to identify specific individuals by name in photographs, unless explicit consent for this is obtained from you in advance. If a specific image of you and/or your child is used online by the Scouts, and you wish to object to us using that image of you or your child (where you are applying on their behalf), then please contact us specifically.

Some Personal data, which may include your name, date of birth, your position in Scouting and your contact details, will be retained by us for up to 5 years after the conclusion of Roverway 2024. This will enable us to keep a record of who has attended, and re-invite people for future events.

The personal details provided will be destroyed securely within 5 years after the end date of Roverway 2024.

All data is held securely in the Scouts digital file systems, including the registration portal provided by EventsAIR.
